TWO LEVELS OF THE FEEDING PROGRAM EXPERIENCE

Fall Challenge

- 1st year feeder (Novice)
- Destination is the "Fall Challenge" at the NE Ag Fair
- Commercial quality feed and animal
- Proving ground for 1st year feeders

Major Shows

- Proficient feeder (Qualified)
- Destination is an approved Major Livestock Show or Bexar County
- Significantly more of an investment of time and finances

EXPECTATIONS AND GOALS

- Livestock experience under supervision
- Allows the application of knowledge and skills learned in the classroom
- Develop a student that is a literate agriculture producer and consumer
- Actively engages the student in production agriculture through entrepreneurship
- Develop skilled and competent varsity feeders
- Provide students with an entry level experience for reasonable financial output

Fall Challenge

Who: First Time Livestock Feeders and any Experienced Feeder who wants to participate.

When: Starts Mid July – Finishes Early November

Shows: Prospect show(s) and Fall Challenge

Misc: Booster Financial Support, terminal animals, points system, low cost, more teacher instruction, only Fall Challenge animals

Major Shows

Who: Experienced Feeder's Only

When: Barn specific start times concludes with Major shows.

Shows: Prospect shows, Bexar County, and Major Shows

Misc: Booster Financial support, no point system, has to be an animal that meets the barn standards, very competitive, less teacher instruction, more student responsibility, more financial risk

TYPES OF ANIMALS

- Market Lambs 3.5 months Mid-July to Early November
- Market Swine 3.5 months Mid July to Early November
- Market Goats 3 months Early Aug to Early November
- Market Broilers 6 weeks Mid-Sept. to Early November
- Market Rabbits- 6 weeks Early of September to Early November

Total Project Breakdown

SPECIES	Upfront Cost	Feed and Supplies	Total Cost
GOAT	\$400	\$225	\$625
LAMB	\$400	\$225	\$625
PIG	\$400	\$380	\$780
RABBIT	\$100	\$0	\$100
POULTRY	\$90	\$250	\$340

Feed and supply cost are broken up monthly and vary depending on other factors. This is a rough estimate of the total amount from previous years.

ESTIMATED INCOME

- Student will receive a terminal resale check for the market price of their animal at the completion of the project period.
- Student will receive a premium check from the James Madison FFA Booster Club
 - To be determined based on student points
 - NE Ag Fair fundraising efforts
- Goal should be to break even or make some money on the project
- Premium average last year was \$1.05 per point, the more raised the more given

EVALUATION PROCESS

- Evaluated by a point system (by teacher)
- Points determine the dollars the student gets back at the end.
- Progress Reports along the way

Point Example

SPECIE	AVG POINTS	MULTIPLIER	TOTAL Points
GOATS	59.8	2.67	159
LAMBS	73.9	2.67	197
PIGS	65.7	2.67	175
RABBITS	63.1	1	63
POULTRY	N/A	1	N/A

The amount per point is determined from the success of fundraising efforts on behalf of the students and parents.

ROLE OF TEACHER

- Serve as the sole source of livestock education for the student in the barn
- Teach the principles of livestock production as related to show projects
- Guide the student and family through the policies and practices of raising livestock in the AMP

ROLE OF TEACHER

- Train the student to be a major show livestock feeder
- Manage the health of the barn
- Conduct educational meetings, clinics and workshops
- Provide communication of the progress of the student

ROLE OF THE STUDENT

- Care for the animal twice daily, every day from start to finish
- Responsible for all cost with the animal
- Communicate with the teacher
- Must attend species Boot Camp
- Must attend Fall Challenge Show Oct. 23-24
- Attend all meetings, clinics, and workshops
- Keep track of individual points progress
- Maintain proper conduct in barns
- Perform barn chores

ROLE OF PARENT

- Monitor the progress of your student
- Assist your student with the project
- Participate on a NE Ag Fair Committee
- Attend James Madison FFA Booster Club and barn meetings
- Communicate with the teacher

Point System Qualification

- 1. A student must earn a minimum of <u>50</u> points from the point system rubric in order to qualify for any potential monies awarded by the James Madison FFA Booster Club.
- 2. A student must earn a minimum of 50 points from the point system rubric to be eligible to participate in a livestock project experience for the next year at the Fall Challenge livestock show

Point System Qualifications Continued:

- 3. If a student earns less than <u>50</u> points that student will not be eligible to participate in the Fall Challenge Livestock show the next year.
- 4. A student must earn a minimum of 70 points from the point system rubric in order to be considered for the major show level next year. The following components will also be used to determine the final eligibility of the student to participate at the major show level

Point System Qualifications Continued:

4. Continued:

- A. The student and parent(s)/guardian(s) must interview with the project supervisor of the species of interest.
- B. The student must receive a positive recommendation from the project supervisor that supervised the student for the Fall Challenge Livestock Show.

- Complete the Fall Challenge Livestock Show
 Commitment Form and submit in person your

- Make final payment for all upfront animal cost by June 9, 2015
